Public transport

The **nearest underground station** to the Berlin School of Economics is Bayerische Platz, on lines U7 and U4. If you are arriving on the U9 get out at Berliner Str. and walk (it's not worth changing).

A **standard ticket** valid for one underground journey in zones A & B costs €2.80; buying four tickets at once is cheaper (€9.00).

A **short-distance ticket** (maximum three stations) for one journey costs €1.70 (four for €5.60).

A **day ticket** for zones A & B costs €7.00; a group ticket (up to 5 people) costs €19.90

Note that Tegel airport is in zone A & B, but for **Schönefeld airport** you need zone C as well (single €3.40, day ticket €7.70).

Conference dinner

The conference dinner will take place at 8.30 pm on Thursday, 14 September at the **Alte Pumpe**, **Lützowstrasse 42**.

- By foot, this will take just over 30 minutes. Guides will be available from outside the Berlin School of Economics around 8.00 pm.
- By underground, the U8 from Badensche Platz takes about 5 minutes to Nollendorf Platz (of Christopher Isherwood fame). This is only two stops so you may use a 'short journey' ticket for €1.70 (or 4 for €5.60). On leaving Nollendorf Platz station proceed north-east along Else-Lasker-Schüle Str. (confusingly, labelled Mackensen Str. on the map) and continue on Genthner Str to Lützow Strasse. At Lützow Strasse turn left, and number 42 is set back on the right hand side.

Please be sure to display your conference name tag. This entitles you to dinner and one drink. Further drinks must be paid for.



Eating on other nights

(a) Near the Berlin School of Economics

There is a selection of restaurants within a short distance of the university:

- Café Cesara, small, economical Croatian restaurant at Badensche Str. 5, half block east of university
- Saltzburger Restaurant, Saltzburger Str 19, 1 block north, 2 blocks east of university, large outside patio
- Bella Italia, economical pizzeria with some tables outside at Bayerische Platz (nearest underground)
- Goldener Stern, German, at Bayerische Platz 4 on the north side of Grunewald Str.
- Taverna Ouisa, Greek, often full, at Grundewald Str. 54, one block west of Bayerische Platz
- Sabor Latino, Peruvian, Badensche Str. 35, four blocks west of university
- Nueva Toscana, slightly more expensive Italian, Badensche Str. 33, also four blocks west, tables outside
- Badensche Hof, Badensche Str. 29, cheap basic menu, friendly bar sometimes with jazz, five blocks west

(b) Within walking distance

There is a good choice of restaurants 15 minutes' walk north-east from the university in Warburg / Eisenacher Str.; these will be quite full, especially on Friday, but two good ones are:

- Chiaia, Italian, Tables outside, Eisenacher Str. 38, tel. +49 30 211 9744

(c) Around Savigny Platz

Savigny Platz is a tree lined square with many restaurants just to the north of West Berlin's main shopping street. It is where the big student demos in the 1960s began. The closest underground is Uhland Str. although coming from the university it is easier to go from Berliner Str. to Kurfürstendamm (3 stops, eligible for short journey ticket) and walk. Restaurants include two reasonably priced Italian, and one more expensive Spanish, all with tables outside:

- La Piazza, Savigny Platz 12
- Mar y Sol, Savigny Platz 5, tel. +49 30 313 2593

Just around the corner is one of Berlin's best jazz clubs, A-Trane, at the corner of Bleibtreu Str. and Pestalozzi Str.

(d) Hackische Markt & the Scheunenviertel

This area in former East Berlin close to the city's historic centre has been largely colonised by the West and by tourists. But the market square and the historic Scheunenviertel are worth visiting. From the university take the U8 at Berliner Str. to Bahnhof Zoo and then switch to the S-Bahn (light overhead railway) and take any east-bound train to Hackischer Markt. This route gives a great view of the new government quarter and parts of the old historic centre (especially the back of the museum complex!) The area is full of restaurants and bars including:

- Hackische Hof, Rosenthaler Str. 40-41, Central European, located in impressive early 20th century example of Berlin courtyards which spearheaded renovation of the area
- Barista, Italian-French, Am Zwingraben 13-15, in the main square under the arches of Hackischer Markt S-Bahn station; tables outside in the square
- Clärchens Ballhouse, unrenovated old dance hall with tables inside & outside, August Str. 24

One of Berlin's other main jazz clubs, B-Flat, is along the railway arches at Dircksenstr. 40.

(e) Other

- **Oranien Str.**, Kreuzberg, one block north of Kottbusser Tor underground station. Centre of West Berlin squatting movement in 1970s & 80s; many cafés from the left / alternative scene and the Turkish community
- **Bergmann Str.** between Mehringdamm and Marheinekeplatz, more middle class (Green voting!) area of Kreuzberg with numerous cafés; Mehringdamm or Gneisenauer Str. underground stations
- **Kollwitz Platz**, attractive green square in centre of area where many oppositional intellectuals lived under the workers' and peasants' state, now highly gentrified but numerous cafés, many with outdoor seating; Senderfelder Str. underground station (here above ground)
- **Kastanien Alle**, two long blocks south-west from Eberwalde Str underground station, more alternative and less upmarket cafés than nearby Kollwitz Platz (with big anti-capitalist slogans on one building). Squatted buildings dating from the workers' and peasants' state.

Committee on Activism I: Artist works/presentations on the politics of technology and ecology

Eclipse and BlindLight/WhiteNoise. Emilia Izquierdo (30 min)

Two experimental video art projects that refer to the politics of technology and ecology: *BlindLight/WhiteNoise* (2016) explores today's blurry divide between nature and technology, creation and destruction, interchanging between the tactile and the digital touch. *Eclipse* (2017) explores our relationship with the digital/technological through the process of combining hand-drawn animation and digital technology, showing footage of violence, totalitarianism, political power games, the fight for social justice and natural phenomena. In addition, the loop video *Mirrors* (2016) explores the effects the neoliberal agenda has on individuals' perception of self and reality.

Air Water Stack. Marlene Ronstedt (30 min)

Air Water Stack maps the uncharted territory of the internet, the Neuland, in a constant stream of images driven by the speed of internet traffic. It is a live stream installation using the technique of web scraping to algorithmically scavenge websites for information, images and videos. The Stack, the internet, as proposed by Benjamin Bratton, is a new layer of governance and control besides the nation state. How is this new territory of governance or the "Neuland," as Angela Merkel called it, to be mapped out? *Air Water Stack* includes a variety of images, charts and streams visualizing the infrastructures which bring the Stack into existence. This combines live footage from the ISS, internet traffic visualization charts, YouTube live streams and DDOS attack maps all coming together in one turbulent installation.

Tectonics/Totems/Humors; Activating the varied ecologies of political economy. Marc Herbst (30 min)

In the array between actually embedded social and economic relations, existing knowledges and potential platforms for political activity or performance rests both actual capacities for socio-ecological transformation and existing institutions that play with all these relationalities. Through a reflection on responses to an open-call submission for climate-based activist and artworks launched by the Journal of Aesthetics & Protest, this presentation will demonstrate the variety of practices, knowledges and institutional forms that allow for both normative and innovative social reproduction. Aligned with the curatorial outcomes of this open call project, the end-point of the discussion will be a series of questions around how institutions of culture and politics reproduce particular forms at the expense of the totality of social relation's capacities.

Committee on Activism II: Films about traditional peoples' struggles to protect their lands in India and Brazil

Minding mines in India. Lorna Collins (46 min + 10 min presentation)

Minding mines in India is a documentary film about indigenous Indians, the Adivasis, and the destruction of their land by mining. The film then addresses the tyranny, punishment and death sentence of the capitalist logos that thwart and colonise Eastern Asia. We discuss the Adivasis' demise from the perspective of a globalised, capitalised consumption machine: President Modi's totalitarian pseudo-democracy. We consider how the Adivasis' difficulties are about capitalism and the Western hegemony across the whole world, with the intention of building a lifeline for the Adivasis and their land. Do we need a new, noncapitalist economy? The answer lies in showing and watching the film, and organizing activism through the moving image. This is radical filmmaking, a radical audience. We watch; we talk; we do.

Sawed Cerrado. Murilo Souza, Dagmar Talga, Jaqueline Talga & Tiago Camarinha (39 min)

Sawed Cerrado is a documentary about the National Campaign in Defense of the Cerrado, a vast tropical savanna ecoregion central Brazil. It presents the resistance of traditional peoples against capitalist destruction through agribusiness, mining and agrarian conflicts. Agricultural monocultures, extensive cattle farming, and huge hydroelectric power plant projects are destroying the life and cultures of the Cerrado. After showing the intense process of degradation of natural resources of the Cerrado, the film also indicates alternative ways to preserve this biome, especially its water, through scientific knowledge and popular wisdom, and to construct new relations of economy and society which empower the traditional peoples of the Cerrado against the attacks of the culture of money and capital.

Committee on Activism III: Films about protest singers in Spain, about neoliberalism, and a fictionalised performance dealing with the 2008 financial crisis

Rianxeira. Karl Ingar Røys (25 min)

La Solfónica is a choir based in Madrid, which grew out of the protests at Puerta del Sol on May 15, 2011, the day after which the “15-M” movement is named. Formed in the run-up to regional elections, its members, inspired by the Arab Spring, demanded change in a system dominated by the conservative People’s Party and the center-left Socialist Workers’ Party, which was in power at the time. Performing classical music at demonstrations, the choir follows the tradition of composers like Giuseppe Verdi, who in the opera *Nabucco* propagated the liberation of northern Italy from Austria. This opera was written in 1841 and became closely linked with the Italian unification movement. David Alegre, conductor of La Solfónica, says the same message still resonates today in Spain, more than 170 years later. At that time he says, “it was a political military occupation but today the occupations are economic and ideological. We apparently have a democracy in Spain but they repress democratic features that allow citizens to participate and really change things”. *Rianxeira* is a film about collective resonance and dissonance as dissidence.

Did you say efficiency, flexibility and stability? María Vidagañ, Raúl de Arriba & Manuel Branco (3 min + 10 min presentation)

Mainstream economics addresses to the public opinion a political message that seems easy to understand: the neoliberal discourse. In order to do that, it has captured some very seductive terms, coming from common use, which have clearly positive (or negative) connotations and a strong subliminal impact. We are talking about terms such as flexibility, stability, liberalization, etc. The seduction of this language is so powerful that any contrary political position is much less attractive and can be easily stigmatized. It is so hard to be against flexibility, stability, liberalization...

Before the nation went bankrupt. Nathaniel Sullivan (46 min)

September 2008. The economy is in ruins, an unprecedented boom is over. The CEOs of the biggest banks have been summoned to the Federal Reserve for an entire weekend. Their task: to solve the world economy and to re-write the rules of finance. Not much is known about what happened that weekend. Until now. *Before the Nation Went Bankrupt* tells the story of the financial crisis through the fictional love letters of JP Morgan Chase CEO Jamie Dimon. The performance is in part an alternative and more libidinal history of our current financial crisis, and an exploration of the metaphoric creep of the neoliberal ideology into all areas of life. Not quite fiction and not quite satire, the letters are a cry in the dark from an insular world that brought us all to the brink of financial, physical and moral ruin.

Committee on Activism IV: Films about border issues between Austria and Italy, about migration in Lampedusa, and about pacifism

One and only, a mountain can not be divided by nations. Andrea Andreco (5 min + 20 min presentation)

One and only is video documentation of an installation and performative project at the border between Italy and Austria. Thousands of men lost their lives on this mountain during the great war trying to conquer the top. Friends, colleagues and acquaintances found themselves on the opposite side of the trenches on the same mountain to shoot each other. Yesterday as today borders breed death. We decided to rise a flag for the landscape in a twenty meters large strip between the Austrian outpost and the Italian trenches, in a no man’s land. Andreco produced for the Pal Piccolo mountain two flags which represent, in the artist’s words, “a mountain that is one and only,” symbolically obliterating the borders.

Persisting dreams. Côme Ledésert (25 min)

Toni is a fisherman in Lampedusa. He sees men, women and children traveling from another continent. Who are these migrants arriving by sea on an island at the entry door of Europe, leaving it as soon as they can if they didn’t die before on their paths? Through Toni’s testimony, intercut by animation that underlines his role of obliged witness, this documentary invites us to question our perception of migrants in Europe – between our tenacious fantasies, Toni’s reality and their persisting dreams.

First skin. Margie Medlin (25 min)

First Skin is an experimental video on the subject of pacifism. It asks a mix of choreographers, artists, a philosopher, a personal trainer and a cook how they think dance and cinema can reflect themes of war imagery. Commissioned for Singapore International Arts Festival, 2015, Margie Medlin responds to Mikuni Yanaihara's dance theatre performance about changes to Article 9, the pacifist article introduced into the Japanese constitution at the end of the Second World War. Made a cinema experience, the video could be described as a radio play. Using disembodied costumes from the original performance, passages of blackness layered with documentary voices to evoke embodied histories, stories and opinions, while abstract images fade in and out to engage the audience's attention.

Committee on Activism V: Film about social movements against disappearances in Mexico***Desaparecidos. Carla Novi (88 min)***

Protests erupted in Mexico after 43 students attending the rural teacher's college of Ayotzinapa disappeared on the 26th of September 2014. People from different backgrounds, classes and ages, united and took to the streets to express their outrage; they organized peaceful rallies, demanding the government take action to find the students. As a result, many citizens involved in the demonstrations have been threatened, abducted as political prisoners, tortured and murdered. *Desaparecidos* follows the stories of a few Mexicans from the current generation who live with the risk of being disappeared because of their participation in the recent protests for the missing 43.

Committee on Activism VI: Film portrait of British Marxist Ralph Miliband, and a film in production about ecological activism in Turkey***Ralph Miliband - the man who hated Britain? Christopher Reeves (55 min)***

In 2013, UK newspaper *The Daily Mail* attempted to smear Labour leader Ed Miliband by linking his policies to the beliefs of his late Marxist father Ralph, a man who they described as hating Britain. The Mail's attack backfired, triggering a new-found interest in Ralph Miliband's thinking and writing. This film portrait explores Ralph's life and ideas and the Marxism on which they were based, including the early experiences that led him to become a socialist, his inspirational teaching, his involvement with the Victory For Socialism group in the post-war Labour Party, his experiences at LSE in the 1960s, his break with Labour over Vietnam, his key writings and his work on *New Left Review* and the *Socialist Register* and in organising The Socialist Conferences in the Thatcher period. The documentary is based around interviews we conducted with Ralph in the early 1990s; interviews with colleagues, friends and family members; and archive film, photos and memorabilia.

Northern forests. Julia Lazarus (short film + presentation – 50 min)

Northern forests is a documentary, currently in production, about the ongoing struggle of Turkish eco-activist group Kuzey Ormanları Savunması ("Northern Forest Defense"), who since 2014 fights against repressive, capital-driven political developments that destroy common spaces in the northern forests of Istanbul. In collaboration with residents, K.O.S. campaigns against the newly opened third bridge over the Bosphorus, a new peripheral highway, and the planned aviation hub on the Black Sea, which are all part of the Turkish government's master plan for greater Istanbul. The activists confront the mounting difficulties in present-day Turkey with courage and humor. *Vive la Solidarité – La Z.A.D. est partout!* shows the group's performative actions in solidarity with activists from *Zone A Défendre*, who are resisting a similar airport project in Nantes, France. The presentation will include video footage by K.O.S. and a slide show taken from film recordings, followed by a discussion on the interplay between activism and documentary film and the relation between filmmaker and portrayed subjects.

Committee on Activism VII: Film about the Lucas Aerospace Plan

THE PLAN - that came from the bottom up. Steve Sprung (180 min)

40 years ago a group of workers in the UK faced with economic crisis, austerity and threats of technology eradicating their jobs, responded with an audacious plan: They developed numerous alternatives to the military products their company (Lucas Aerospace) made, including a wind turbine and fully functioning hybrid car. *THE PLAN* is the story of how these young skilled workers flew in the face of not only recession but the free market philosophy that was gaining traction at that time. It tells this ground-breaking story from the perspective of the present, combining memories with reflections on the situation today and beyond. It interrogates the forces that opposed the workers' plan – company, governments, trade unions and the neo-liberal philosophy that was in ascendance – and exposes an operational logic that still blocks the sort of solutions these pioneers offered.

Committee on Activism IX: Films about UN peacekeeping in Haiti, and the aftermath of the Greek civil war

It stays with you: UN peacekeeping in Haiti. Cahal McLaughlin & Siobhán Wills (50 min)

In 2004, the UN dispatched a peace-keeping mission to Haiti after the overthrow of the democratically elected President Aristide. Between 2005 and 2007, UN peacekeeping troops, named MINUSTAH, carried out several raids on Cite Soleil, a severely economically-depressed neighborhood of Port au Prince. Scores of civilians were killed and many more injured. Using participatory practices, we have worked closely with the affected community to ensure they are in agreement with the film's content, structure and distribution. We have also interviewed Ricardo Seitenfus (OAS representative in Haiti); Professors Camille Chambers and Ilionor Louis from l'Université d'État d'Haiti; Philip Alston, ex-UN Rapporteur on Extrajudicial Killings; Christof Heyns, member of the UN Human Rights Committee; John Carroll, a medical consultant; Beatrice Lindstrom, Institute for Democracy and Justice in Haiti (Boston) and Seth Donnelly (Labour Rights activist). The film is co-directed by Cahal McLaughlin, Queens University Belfast, and Siobhán Wills, Transitional Justice Institute, Ulster University.

Next year in Lerin. Jill Daniels (45 min)

This is a film about the Greek Civil War and ethnic Macedonians exiled as children from their homes in northern Greece. In 1948, during the war, Vassil, his friend Nikola, and 28-thousand children, Greek and Macedonian, were taken from their villages, leaving their mothers behind, by the communist-led Democratic Army and raised in orphanages in Eastern Europe. While the Greek children were brought back to Greece after the war ended, most of the Macedonian children were not allowed back and never saw their mothers or their birthplaces again. Years later the 'children' marked the anniversary of their journey. They dance and sing and talk movingly of their feelings of identity and of their villages. Today not much has changed. While the villages in northern Greece are empty, and the Greek civil war has faded into history, the Macedonian 'children' are still its forgotten victims.
